### Terms and Conditions of Entry: 2017 San Remo Art and Photographic Show

1. ALL entries must be submitted electronically and details for commission payments provided at time of entry.
2. All entries must be completed in one submission.
3. All exhibits must be for sale and original, un-copied, recent work of the exhibitor not previously displayed in this Show.
4. A maximum of 5 entries may be submitted. (A pair is to be treated as 2 entries with the fee payable for each entry.)
5. A non-refundable fee of \$15.00 per art exhibit or \$10 per photographic print is payable. Exhibits, including frame, must not exceed 120cm x 120cm .
6. The exhibitor shall pay to the Rotary Club of Phillip Island and San Remo 25% of the sale price of any exhibit sold at or as a result of the exhibition.
7. Work must be suitably mounted, framed and fitted with a secure device for hanging. Stretched canvases are considered framed.
8. Entries must be clearly marked on the back of the exhibit with the title, your name, address and price.
9. The Committee and Judges reserve the right to reject any entry. The decision of the Judges will be final and no correspondence will be entered into.
10. The Rotary Club will take every care of exhibits, but will not accept any responsibility for the loss of, or damage to any exhibit whilst in transit, on display, in storage or otherwise.
11. Entries will be accepted at the San Remo Recreation Centre, Wynne Road, San Remo (follow signs) from 10am to 4pm on Wednesday 8th March and 10am to 1pm on Thursday 9th March 2017.
12. Entries must remain on display until 1.30 pm Monday 13th March 2017. Unsold exhibits must be collected after the Show between 2pm and 5.30pm. To collect works the exhibitor or an agent must produce proof of identification and the initial receipt issued. Uncollected works may be disposed of at the Committee's discretion.
13. If you are registered for GST, please indicate clearly that your catalogue price includes 10% GST, which you are responsible for paying to the ATO. Should a purchaser request a Tax invoice, they will be given your contact details so that you can provide them with a tax Invoice.
14. Entries Close Friday 10th February 2017. No paper entry will be accepted. ALL entries must be completed online.
15. No entry is deemed accepted until the non-refundable, full entry fee is paid and cleared. Payment preferred to be by: PayPal. Alternative method is electronically to the San Remo Art Show, BSB 633-000, Account No. 14011 5486, Reference, **Your Artist Registration Reference Number**. NOTE: Entries will not be accepted without payment.
16. The Artist/Photographer permits the Rotary Club to have any work reproduced for publicity purposes.
17. By entering this Show, you permit the Rotary Club to keep you informed of all Art Show related activities.
